## What is the Victims of Discrimination Support Service?

It is a free, state support service for possible victims of racial or ethnic discrimination, given by the Council for the Promotion of Equal Treatment and Non Discrimination Against Racial or Ethnic Origin, professional association affiliated with the Spanish Ministry of Health, Social Services and Equality, through the General Directorate for Equal Opportunities.

The service offers support and independent assistance to those who are or have been discriminated against, based on their racial or ethnic origin, in any context (education, health, housing, job, etc.).

The Council provides its services through an office network of eight organisations specialised in assistance to victims of discrimination:

- ▶ Spanish Red Cross
- ▶ CEPAIM Foundation
- ▶ Fundación Secretariado Gitano
- ▶ Movement against Intolerance
- ▶ Movement for Peace, Disarmament and Freedom –MPDL–
